Thank you for submitting the draft “City of Boston Open Space and Recreation Plan 2015-2021” to the Metropolitan Area Planning Council (MAPC) for review.

The Division of Conservation Services (DCS) requires that all open space plans must be submitted to the regional planning agency for review. This review is advisory and only DCS has the power to approve a municipal open space plan. While DCS reviews open space plans for compliance with their guidelines, MAPC reviews these plans for their attention to regional issues generally and more specifically for consistency with *MetroFuture*, the regional policy plan for the Boston metropolitan area.

The plan contains all of the elements that MAPC looks for in order to determine consistency with *MetroFuture*. The Boston plan has a very comprehensive treatment of regional open space issues, and you are to be congratulated for incorporating this perspective. Additionally, it includes an extensive analysis of environmental justice and equity with regard to access to open space and recreation resources across the City, an issue that is a priority for both DCS and MAPC.

MAPC enjoyed working with the City of Boston on the staff workshop to develop the Seven Year Action Plan. Boston’s Open Space and Recreation Plan is very thorough and it should serve the city well as it continues its efforts to preserve open space and provide for the recreational needs of its residents.
